 14 mi. south of Frederick, MD / 11 mi. north of Leesburg, VA, Just south of Rt#28/Rt#15  
 Park is adjacent to “Art at The Point” Outdoor Festival - Stick around for Fine Art & Music

**The Course**

Historic C&O Canal National Historical Park Towpath – starts at the new boat ramp, runs west on the towpath 5 (or 2 ½ Kilometers) to turnarounds & back to the start. Course is on varied stone to dirt surface, and does not enter vehicle traffic at any time. **NO** bicycles, wheelchairs, skates, pets strollers, baby joggers, headsets, during the race.
